2. SPECIFICATIONS AND DETAILS OF Breath Alcohol Analyzer with Printer, Camera and GPS

- Breath Analyser should have built-in Alcohol specific Electro Chemical Fuel Cell Sensor. It should have blow option from top of the unit and not from side so that the exhaled breath of the subject shall be directed back to the subject and not to the testing officer so as to protect the officer from any airborne diseases
- 2. Breath Analyser should be handy, portable and user friendly. The dimensions of breath analyser unit with printer shall not exceed 190x90x40 mm and weight shall not exceed 320 gms (including battery)
- 3. Breath Analyzer shall have Automatic and Manual sampling methods. It should have Passive mode (for screening the subjects), Active mode and Refuse mode of testing.
- 4. Breath Analyzer should be operated with easy to use full graphic colour touch screen display. The size of LCD Touch Screen Display should not be less than 3.2". It should be possible to operate the breath analyzer unit with buttons as well and there shall be no more than 3 buttons to do so.
- 5. Unit Accuracy should be +/- 5 mg/100ml at 100mg/100ml and +/- 5% above 100mg/100ml.
- 6. Operating Temperature should be -10 to +55 Degree Celsius Ambient temperature.
- 7. Test should be done with one way check valve mouth piece to eliminate the possibility of suck back of atmospheric air during sample capture.
- 8. Unit shall be able to show reading in mg/100ml, BAC% and mg/L and this should be switchable from the unit itself.
- 9. Breath Analyser should have an internal memory of minimum 60,000 measured values with date, time and other entered details on FIFO basis. The unit should be able to connect to a PC to transfer all stored data for further analysis.
- 10. The Unit shall have built-in 5MP Camera to capture the image of the violator and store the image in built-in 16GB memory SD card. The image shall automatically be captured and stored while the subject is blowing during active mode of testing. The camera shall be built-in to the unit housing and not shall be a pop-up or projected camera which is prone to easy breaking.

- 11. The Breath Analyzer unit shall have built-in GPS and the location coordinates shall be stored with the record in the memory and shall be printed on the receipt as well.
- 12. Deletion of stored records shall not be possible from the unit at all. Even after putting any password or PIN# it shall not be possible to delete the records from the unit. Record deletion shall only be possible after connecting the unit with PC using the OEM provided software only.
- 13. Breath Analyzer should have built-in white LED light for reading breath analyzer receipt, Violator's DL, Vehicle RC or any other paper in low light condition.
- 14. Breath Analyser should have built-in thermal printer.
- 15. Breath Analyzer shall work on built-in 7.4V rechargeable Lithium Ion/Polymer Battery.
- 16. Each violation printed receipt shall print the calibration up to date of the unit so that by looking at the receipt it can be determined if the unit was calibrated at the time of testing or no.
- 17. After the subject is tested the BAC reading (Negative or Positive) shall be stored in the record memory automatically and the unit shall not confirm from the user whether to save in record memory.
- 18. Unit should have full graphic LCD colour touch screen display of not less than 3.2" to enter details like Driver Name, Vehicle No., License No. etc.
- 19. Breath Analyser should not be affected by Acetone, Paint etc.
- 20. Breath Analyser should be able to detect Alcohol up to 550 mg/100 ml.
- 21. The response time should be less than 5 and 30 seconds for 0 and 550 mg/100 ml respectively.
- 22. The manufacturer of the breath analyser unit shall be ISO9001:2015 certified.
- 23. The Breath Analyzer shall have been tested at any NABL accredited laboratory in India. The test report shall be for the particular quoted model only, mentioning clearly the quoted unit's model no.
- 24. Each Breath Analyzer unit shall be supplied with a suitable carry bag, 05 mouth pieces, 03 paper rolls, Battery Charger and Data Cable.

3. **Scope of the Contract**

a. Tender is invited from the manufacturers in India or their authorised dealer for the supply of **Breath Alcohol Analyzer with Printer,**Camera and GPS.

- b. The bidder shall give proper training for using Breath Alcohol Analyser.
- c. The bidder is having service support facility in Kerala and shall attend any defect within 48 hrs. Phone Number in Kerala / Toll free number shall be given.
- d. The bidder shall offer warranty for a period of 12 months minimum.
- e. The supplier should deliver the item at KSRTC Chief Store, Pappanamcode 695018 (Thiruvananthapuram Dist.).
- f. Bidder should be able to start delivery of materials within 15 days from the date of order.

4. PRE QUALIFICATION CRITERIA

- The bidder shall be a manufacturer of Breath Alcohol Analyzer with Printer, Camera and GPS in India or their authorised dealer.
- b. Bidder should have GST Registration.
- c. The bidder shall be 2 years experience for the supply of Breath Alcohol Analyzer with Printer, Camera and GPS in Government organisations in Kerala / Kerala Motor Vehicle Department.
- d. The bidder shall have service support facility in Kerala.
- e. The bidder should have annual turn over of atleast Rs.20 Lakh per each year for the last three financial years (2021 2022, 2022 2023, 2023 2024).

5. General Conditions of the contract

- a. Bidders should remit the required Tender Fee and Earnest Money Deposit (EMD) in 'Online mode' through SBI/NEFT, as per 1(e) and I(f) of the Notice Inviting Tender. No exemption in the case of EMD and Tender Fee. <u>Bidders should ensure and convince themselves that the online payments made by them have been successfully transferred. KSRTC shall under no circumstances be responsible for failed transaction of the payments due to non-compliance of any online banking procedure and consequent rejection of tender.</u>
- b. Firms who have been blacklisted by the Central Government/ any State Government / any State Transport Undertaking will not be considered.
- c. The L1 bidder shall submit 1 No. of Breath Alcohol Analyzer with Printer, Camera and GPS for assessing suitability and performance as per tender specifications for a period of 3 to 5 days at their own cost within 7 days from the date of intimation by e-mail. If the bidder failed to submit the sample within time, the bidder will become disqualified in the tender. If the Breath Alcohol Analyzer with Printer, Camera and GPS supplied will not meet the required specifications then the bidder become disqualified and the bidder have to take back the Breath

- Alcohol Analyzer with Printer, Camera and GPS at their own cost. If the sample found suitable, sample shall be returned only after completing the supplier as per purchase order conditions.
- d. <u>Rate Firmness</u>:- The quoted rates shall be firm for a period of 12 months from the date of opening of financial bid. No enhancement of rates once accepted will be considered during the contract period.
- e. The details such as name of manufacturer, make/brand etc. should be provided in the tender.
- f. Tenders of those bidders who do not successfully remit Tender fee and EMD online or do not upload the above mentioned document (digitally signed) will be rejected. The bidders should possess digital signature for uploading the documents.
- g. The successful tenderer shall submit an agreement (Appendix I) in the prescribed format within 7 (Seven) days from the date of Purchase Order.

6. Documents to be uploaded in the e-tender Portal

- a. Scanned copy of valid manufacturing license in the case of manufacturer. In the case of Dealer, they should upload the scanned copy of Manufacture's Authorisation Form for Dealer as per Annexure-D duly filled signed and stamped by the bidder.
- b. GST Registration Certificate of bidders to be uploaded.
- c. The bidder should upload the copy of Tax Invoice of the offered make and brand of Breath Alcohol Analyzer with Printer, Camera and GPS supplied to Kerala Motor Vehicle Department / Govt. organisations in Kerala.
- d. The bidder should upload the details of service centre facility in Kerala with Phone Number / Toll free number.
- e. The bidder should have annual turn over of atleast Rs.20 Lakh per each year for the last three financial years (2021–2022, 2022-2023, 2023–2024). Please upload ANNEXURE-B after filling all the columns and duly filled, signed and stamped by the bidder certified by Chartered Accountant / Auditors.
- f. This Notice Inviting Tender (all pages) duly filled signed and stamped by the bidder should be scanned and uploaded.
- g. Scanned copy of ANNEXURE-A, General Information about the tenderer after filling all the column and duly signed and stamped by the bidder.
- h. Bidders who have been blacklisted by the Tender Inviting Authority or by any State Govt. or Central Government / Organization should not participate in the tenders during the period of blacklisting. An affidavit as per format in Annexure—C (Anti-Blacklisting Affidavit) should be submitted along with the technical bid.

- The details of guarantee, make/brand and also scanned copy of printed Leaflet /Catalogue/Brochure of the manufacturer for the quoted item should be uploaded.
- j. Scanned copy of specification sheet as per Annexure -E shall be duly filled signed and stamped by the bidder with full address and date should be uploaded.
- 7. Instructions for submitting Financial bid :
 - a) The bidder should offer the basic rate for 1 No. of Breath Alcohol Analyzer with Printer, Camera and GPS, discount, GST separately. The rates shall be submitted in BOQ portion of the corresponding Tender published in website www.etenders.kerala.gov.in
 - b) The rate quoted should be for door delivery at KSRTC, Chief Store, Pappanamcode, Thiruvananthapuram (Dist.) 695018.
 - c) GST should be calculated exactly and entered in the respective column of BOQ.
 - d) GST should be calculated exactly and entered in the respective column of BOQ. In the BOQ the GST is to be mentioned in rupees, not in %, therefore bidders are requested to upload the rate accordingly.
 - e) If the amount of GST is not entered in the respective column of BOQ, such bidders will not be eligible for revised levies declared from time to time.
 - f) The quantity of item may increase or decrease. The tolerance limit shall not be more than plus / minus fifteen percent (± 15%) as per the provisions of Kerala Store Purchase Manual.

8. TENDER PROCESS:

The tender evaluation will be undertaken in four rounds.

Round 1- Opening of technical bid documents

Round 2 – Document evaluation.

Round 3 - Opening of Price Bid.

Round 4 – Sample Evaluation.

1. Round 1- Opening of technical bid documents

The documents uploaded shall be opened at the time and date mentioned. The prospective bidders or their authorized representatives can present, if required by them.

2. Round 2 - Document evaluation:- The format for submission of the technical bid as per annexures and submission in any other format or

absence of requisite information will lead to rejection of bids in the round 2 evaluation itself. The prospective bidders are advised to submit all information and supporting documents that are required to prove their competency and claims for technical evaluation.

The commercial terms and documents submitted as part of the bids shall be scrutinized by a Bid Evaluation Committee constituted by the Tender Inviting Authority.

The Tender Inviting Authority may call for additional documents/clarifications through e-tender portal.

The list of those who come out of the evaluation of the documents successfully as well as those rejected (with reasons for rejections) will be published on the website of KSRTC (www.keralartc.com) and objections/remarks against the list will be invited. The objections /remarks received before the date and time specified in the notice will be considered by the Tender Inviting Authority and the final list of successful bidders of round 2 will be published.

3. Round 3 - Opening of Price Bid.

The bidders who are qualified in round 2 shall be considered for Round -3. The BOQ/PRICE BID of those bidders who do not satisfy even any one of the pre-qualification condition will not be opened.

4. Round 4 - Sample Evaluation.

The L1 bidder shall submit 1 No. of the offered brand and model of the Breath Alcohol Analyzer with Printer, Camera and GPS for a minimum period of 3 to 5 days to assess the suitability as per tender specifications. If the bidder failed to submit the sample within 7 days of intimation through the e-mail ID provided along with this tender, the bidder become disqualified in the tender without any further notice. If the L1 bidder become disqualified sample will be obtained from the L2 bidder and so on. If the sample is not suitable then the bidder have to take back the sample and they will not consider for purchase. If the sample found suitable it will be be returned only after completing the supplies as per purchase order conditions.

9. <u>SELECTION OF SUPPLIERS:</u> The selection of suppliers will be made from among the technically qualified bidders who are pre-qualified by uploading all the mandatory documents as per Clause No. 5 of NIT and their sample shall be suitable.

- 10. Opening of e-Tender will be done at the time and date noted in the e- tender portal at the Office of the Chairman and Managing Director, KSRTC.
- 11. <u>Payment:</u> Payment for the materials will be made only after receipt, inspection and acceptance of the supplied items at the destination specified by KSRTC.
- 12. <u>Liquidated damages for non supply and performance:</u> The successful bidders shall supply the ordered quantity of materials as per the delivery schedule given by KSRTC. If materials are not supplied as per supply schedule given by KSRTC, liquidated damages will be realised from the supplier at the rate of 0.5% of the Cost of item per week for each week or part there of, up to a maximum deduction of 10% of the Contract prices and there after the Corporation will consider the termination of the contract at the risk and cost of the contractor.
- 13. <u>Earnest Money Deposit</u>:- The EMD will not carry any interest. The EMD will be forfeited, if the successful Bidders fail to execute agreement and furnish Security deposit, or in the event of withdrawal of offer once made or in the event of putting forth any conditions which are against or contradictory to the conditions of this Notice Inviting Tender.
- 14. <u>Security Deposit</u>:- The successful Bidder has to furnish a Security Deposit equivalent to 5% of the total value of purchase contract awarded to them, before executing the agreement. *The security deposit carries no interest*. The EMD amount will be adjusted in the security deposit in the case of successful bidders. The Security Deposit can be remitted either in the form of Demand Draft from any Nationalised/Scheduled Bank drawn in favour of FA & CAO, KSRTC, Thiruvananthapuram, payable at Thiruvananthapuram or in the form of Bank.

 Guarantee from any Nationalised/Scheduled Bank with a claim period of minimum 3 months beyond the expiry of the contract including warranty period. The security deposit will be forfeited, if the contractor fails to complete the supply as per the schedule issued by KSRTC or in the event the Bidder fails to settle any claim including the warranty claims. The security deposit will be refunded only after the satisfactory completion of the contract including warranty claims or penalty settlement.
- 15. Agreement:- The successful bidder shall have to execute an agreement within 15 days from the date of issue of purchase order, incorporating the Terms & Conditions of Tender and as per Kerala Stores Purchase Manual. The agreement has to executed in the prescribed form issued from KSRTC, in Rs. 200/- INDIAN STAMP PAPER after furnishing the Security deposit equivalent to 5% of the total value of purchase contract awarded to them, as per provisions of Kerala Store Purchase Manual, for the due fulfilment of the contract. If the bidders are not

- willing to execute the Agreement and Security deposit, their offer will not be considered.
- 16. The Corporation reserves the authority to consider the offer in part or full as desired.
- 17. The bidders have the liberty to resubmit fresh tender/documents till the last date and time of submission of the e-tender.
- 18. Resubmission of offer will not be allowed after the time and date fixed for bid submission. The offer once made cannot be withdrawn or modified after the closing of e-tender under any circumstances. Withdrawal or modification of the offer once made in e-tender will be resulted in the forfeiture of EMD remitted. In such cases the bidder will not have the right to claim the refund of EMD.
- 19. Supply of the materials should be completed within the time stipulated by KSRTC, failing which the Corporation will procure the materials from other sources at the risk and cost of the Bidder.
- 20. Details of Warranty offered by the supplier should be specified clearly.
- 21. The Chairman and Managing Director KSRTC reserve the right to make any modifications or additions in this notice in the event if it is felt that it is in the public interest.
- 22. The decisions of the Chairman and Managing Director KSRTC will be final and legally binding in these tender proceedings. All questions/disputes arising under / out of or in connection with this tender shall be decided by the Chairman & Managing Director of KSRTC and his decision shall be final and legally binding in these tender proceedings.
- 23. Disputes, if any shall be settled through mediation and the Corporation will notify mediating official from time to time and only when mediation is failed, litigation with in the jurisdiction of the courts at Thiruvananthapuram and Ernakulam need to be sought.
- 24. Any dispute arising out of this Tender procedure shall be under the Jurisdiction of Thiruvananthapuram court.

25. GENERAL INSTRUCTIONS TO BIDDERS

- a) Tender shall be made in English.
- b) Firms who are not blacklisted by KSRTC or by Govt. of Kerala can participate in the tender.

NOW THESE PRESENTS WITNESS AS FOLLOWS:

- (1) (A) In case where along with the tender samples have been forwarded to the Corporation and the samples approved, the contractor agrees to supply the materials according to the approved samples. In other cases, the contractor agrees to forward samples to Corporation for approval, if so required, and then to supply materials according to such approved samples. When samples are not required the contractor agrees to supply according to standard specification.
