4. Tender will be opened at 15.00 hours on **03.04.2025** in the presence of the bidder or their authorized nominees available at the time of opening.

Successful bidder has to execute an agreement as per the provisions of Kerala Store Purchase rules after furnishing a security deposit equal to 5% of the total cost of materials ordered for the fulfillment of the contract. The security Deposit will be refunded only after the successful completion of the contract. **No interest will be paid for the Security Deposit.**

6. Supply of the material should be completed within the time stipulated by the Corporation or within the time mutually agreed to failing which the corporation will procure the materials from the other sources at the risk and cost of the bidder.
7. The successful bidder shall arrange the supply of the item in minimum 10 equal monthly lots as per supply schedule during the contract period of 12 months
8. No enhancement of rates once accepted will be considered. The quoted price should firm for a minimum period of 12 months from the date of PO.

10. Warranty period should be specified.
