1. Introduction

KSRTC SWIFT Ltd, (A govt. of Kerala Undertaking) operates long distance buses and Electric buses for KSRTC. Presently KSRTC SWIFT Ltd owns 444 buses.

KSRTC SWIFT Ltd. intends to engage an agency for the supply, installation, commissioning, and maintenance of Wi-Fi facilities in its Premium AC Superfast buses (13 Nos.) operated by KSRTC-SWIFT Ltd buses for a period of one year extendable for further one more year based on the evaluation of performance for the successful bidder.

2. Scope of Work

Supply and installation of Wi-Fi hardware.

Configuration and integration with the existing bus fleet infrastructure. Provision of high-speed internet bandwidth (minimum 10 Mbps per bus).

Comprehensive testing and commissioning of the system.

Maintenance and technical support for one year.

The Deputy General Manager (Technical), KSRTC SWIFT will be the coordinating officer from KSRTC SWIFT Ltd and the contact number is 0471-2993117.

3. Technical Specifications

Wi-Fi hardware must support dual band (2.4 GHz and 5 GHz) with a minimum standard of IEEE 802.11ac or higher.

Minimum bandwidth requirement: 10 Mbps per bus, ensuring uninterrupted connectivity.

Security protocols must include WPA3 encryption and compliance with CERT-In guidelines.

The system must ensure uptime of at least 99% per month, with penalties for non-compliance.

4. Service Level Agreement (SLA)

Vendors must respond to service issues within 4 hours and resolve them within 24 hours.

Monthly performance reports are mandatory.

Penalty for SLA breaches:

Rs. 5,000 per hour for downtime exceeding the agreed limit.

Rs. 10,000 per day for delays in installation beyond the stipulated timeline.

5. Revenue Sharing Model

Vendors may generate revenue through advertisements on the Wi-Fi login portal with prior approval from KSRTC-SWIFT Ltd. Revenue will be shared in a ratio of 70% (KSRTC): 30% (Vendor).

6. Eligibility Criteria (Pre-Qualification)

- a. The bidder must be a registered entity in India with valid licenses.
- b. Minimum 1 year of experience in providing Wi-Fi solutions in public transport or similar projects.
- c. Successfully completed at least one similar project of comparable scale.

- d. Average annual turnover of at least ₹20 Lakhs over the last two financial years (2021-22 to 2023-24).
- e. Must have a fully operational office in Kerala.
- f. GST registration is mandatory.

6. General Conditions of the contract

- a. Bidders should remit the required Tender Fee and Earnest Money Deposit (EMD) in Online mode through SBI/NEFT, as per 1(d), 1(e) and I(f) of the Notice Inviting Tender. No exemption in the case of EMD and Tender Fee. Bidders should ensure and convince themselves that the online payments made by them have been successfully transferred. KSRTC SWIFT Ltd. shall under no circumstances be responsible for failed transaction of the payments due to non-compliance of any online banking procedure and consequent rejection of tender.
- d. The tenderer should quote the cost of the supply, installation, commissioning, and maintenance of Wi-Fi facilities for one bus in Premium AC Superfast buses (13 Nos.) as Appendix-1 and in BoQ.
- e. Normally the work will be awarded to the tenderer who quotes the lowest amount in tender. The decision of the Chairman & Managing Director on all matters arising out of this Notice / Contract will be final, conclusive and legally binding on all parties concerned.
- f. Opening of E-Tender will be done at the time and date noted in the e- tender portal at the Office of the Chairman and Managing Director, KSRTC.
- g. Firms /Proprietors who have been blacklisted by the Tender inviting Authority/ Central Government/ any State Government / any State Transport Undertaking will be considered disqualified for participating in the tender during the period of blacklisting. An affidavit as per format in Annexure IV (Anti-Blacklisting Affidavit) should be submitted along with the technical bid.

7. MODE OF SUBMITTING TENDERS

- 1. Tender documents shall be submitted through e-Tender. One for **Pre-Qualification Bid** and the other for **Price Bid**.
- 2. The tenderer shall submit the tender documents as specified hereunder.
- 3. The relevant documents to be uploaded shall not be interchanged.

8. Documents to be uploaded along with Pre-Qualification Bid

9. TENDER PROCESS:

The tender evaluation will be undertaken in three rounds.

- **Round 1** Opening of technical bid documents
- **Round 2** Document evaluation.
- **Round 3** Opening of Price Bid.

1. Round 1- Opening of Pre-Qualification bid documents

The documents uploaded shall be opened at the time and date mentioned.

2. Round 2 Document evaluation:-

The terms and documents submitted as part of the bids shall be scrutinised by the Tender Inviting Authority. The Tender Inviting Authority may call for additional documents/clarifications through e-tender portal. The list of those who come out successfully of the evaluation of the documents as well as

those rejected (with reasons for rejections) will be published on the website of KSRTC (www.keralartc.com), KSRTC SWIFT (www.ksrtcswift.kerala.gov.in) and objections/remarks against the list will be invited. The objections/ remarks received before the date and time specified in the notice will be considered by the Tender Inviting Authority and the final list of successful bidders of round 2 will be published.

3. Round 3: Opening of Price Bid.

10. Opening of PRICE BID

- a. The PRICE BID of those bidders, who satisfied all of the Prequalification Criteria, shall only be opened for further consideration. The PRICE BID of those bidders who do not satisfy even any one of the pre-qualification condition will not be opened.
- b. Opening of e-Tender will be done at the time and date noted in the e-Tender portal at the Office of the Chairman and Managing Director, KSRTC.
- c. The bidders have the liberty to resubmit fresh tender/documents till the last date and time of submission of the e-tender.
- d. Resubmission of offer will not be allowed after the time and date fixed for bid submission. The offer once made cannot be withdrawn or modified after the closing of e-tender under any circumstances. Withdrawal or modification of the offer once made in e-Tender will be resulted in the forfeiture of EMD remitted. In such cases the bidder will not have the right to claim the refund of EMD.
- e. The Chairman and Managing Director KSRTC SWIFT Ltd reserve the right to make any modifications or additions in this notice in the event if it is felt that it is in the public interest.

11. GENERAL INSTRUCTIONS TO BIDDERS

- a. Tender shall be made in English.

- d. The bids will be opened online through the e-GP website www.etenders.kerala.gov.in the KSRTC, Transport at Bhavan, Thiruvananthapuram. If the e-Tender opening date happens to be a holiday or non-working day due to any valid reason, the Tender opening process will be done on the next working day at the same time and place specified. Any change in the opening date/time/venue due to other reasons shall be informed by way of Corrigendum published in the e-GP website.
- e. <u>DIGITAL SIGNATURE CERTIFICATE</u>:- Bidders will have to procure legally valid Digital Certificate as per Information Technology Act, 2000 for digitally signing their electronic bids. - g. Bidders are advised to note the Tender ID and Tender No. & Date for future reference.

- h. All uploaded scanned documents should contain the signature and the office seal of the bidders and should be digitally signed while uploading in e-tender portal. Documents uploaded without digitally signing shall entitle rejection of the Tender.
- i. The digitally signed Tender document and other specified documents shall be submitted online through the e-GP website www.etenders.kerala.gov.in well in advance before the last date and time. No submission shall be allowed after the last date mentioned.
- j. Bidders are advised to go through all conditions of the Notice Inviting Tender and the Tender documents carefully and to comply them to avoid rejection of their tender.
- k. Furnishing of any false information / fabricated document would lead to rejection of the tender at any stage.
- 1. The bidder shall bear all costs associated with the preparation and submission of its bid and KSRTC SWIFT Ltd, Thiruvananthapuram, hereinafter referred to as Tender Inviting Authority, will in no case be responsible or liable for these costs, regardless of the conduct or outcome of the bidding process.
- m. Conditional tenders will be summarily rejected.

12. GENERAL TERMS AND CONDITIONS

- a. The Tender Form containing the tender conditions can be downloaded from the e-Tender site. The cost of tender form shall be paid through e-payment. Cost of the tender form is not refundable under any circumstances.
- b. The tenderer should quote the cost for the supply, installation, commissioning, and maintenance of Wi-Fi facilities to the travelers for per bus in BoQ.
- c. The work will be confirmed to the Party who quotes the lowest amount in the Tender.
- d. The Company shall normally accept the lowest offer in the tender but the Company reserves the right to accept or reject any of the tenders without assigning any reason whatsoever, if such a step is deemed necessary to safeguard the interest of the Company.

- e. The tenderer should specify in the tender the experience he possesses and the extent of the present business in the relevant field.
- f. The Earnest Money of Rs.20,000/- should be remitted through e- payment in favour of the Financial Advisor & Chief Accounts Officer, Kerala State Road Transport Corporation, Transport Bhavan, Thiruvananthapuram.
- g. If any tenderer withdraws his tender on or after the specified/prescribed time for opening Tender/Auction, the EMD shall be forfeited forthwith. Withdrawal of tender by the successful tenderer will entail forfeiture of EMD without further notice. Moreover, the difference in amount between the highest bidder and the second highest bidder will also be realised from the successful tenderer invoking provisions of Kerala Revenue Recovery Act, 1968 as the case may be. The loss sustained due to the withdrawal of a successful tenderer will be realised from the tenderer in any manner Company may think fit.
- h. The amount remitted as Security Deposit will be released to the party after the satisfactory completion of the contract period without interest.
- i. The successful tenderer shall be required to execute an Agreement (Licence Deed) in stamped paper worth Rs.200/- (Rs. Two Hundred only) as per the draft prescribed by the Company embodying the conditions specified herein and such other terms and conditions as may be decided from time to time if found necessary.
- j. The electoral ID card & Aadhar card number of the licensee and witnesses has to be entered in the agreement and it's self attested copy should be made part of Agreement.
- k. In the case of failure of the successful tenderer to fulfil the conditions herein stated, before the commencement of the contract or to abide by the terms and conditions of the agreement, the Chairman & Managing Director will have the right to cancel the contract and to award the contract to another contractor or to carry out the work by the Company as Company deems it fit and any amount paid by the bidder to the Company will be forfeited. Besides, the successful bidder shall be liable for any loss caused to the Company by reason of cancelling the contract. The amount due to the Company shall be realised under provisions of Revenue Recovery Act as arrears of land revenue or

- under the provisions of law in force from any amount due to the licensee on any account or in any other manner as the Company may deem fit.
- 1. No representation for the escalation of rates once accepted will be entertained under any circumstances.
- m. The Company shall have the power to cancel the contract entered into with the successful bidder with one-month notice, if it considers that such cancellation is necessary in the interest of the Company / general public. The successful bidder shall abide by such decision of the Company.
- n. The contractor shall be liable to pay taxes or any other amount levied by the Government, local or other authorities from time to time. The contractor shall remit GST if any, along with each payment. If the licensee fails to remit these statutory levies / taxes, the particular amount with interest, penalty imposed by Government / local bodies (i.e. taxes and levies etc.) will be realised from the amount remitted by the contractor towards security deposit. If such liability exceeds the Security Deposit, it will be realised under the provision of Kerala Revenue Recovery Act or any other law then in force in respect of present as well as future claims.
- o. The security amount will be refunded to the contractor after the expiry of the licence period and after the successful completion of the contract period and upon clearance of dues, if any, due to Government or local bodies, as well as after deducting liability if any.
- p. If the contractor retracts from the fulfilment of the contract, he shall be liable to compensate the loss, if any, sustained to Company on account of this. The loss so sustained will be realised from the defaulter invoking provisions of Revenue Recovery act or by invoking provisions of any other law.
- q. Any damages occurred to the buses, parts, wiring and battery while or due to installation, commissioning or maintenance of Wi-Fi facilities will be the responsibility of the contractor and any loss on account of this will be recovered from the contractor.
- r. The contractor has to install, commission or maintenance the Wi-Fi from the location as intimated by KSRTC/ KSRTC SWIFT Ltd that is at KSRTC Depots in Kerala, when the buses are available. Any delay for delivery will be treated as revenue loss to the company and will be recovered from contractor.

- s. List of buses and respective depots will be provided before the execution of agreement.
- t. The contractor has to submit the original invoice, for the approved amount for the respective category of bus, installation certificate of the contractor along with the copy of Goods Received (GR) Note by the Unit officer concerned, KSRTC to the General Manager, KSRTC SWIFT Ltd.
- u. The payment for the contractor will be processed monthly after the receipt of the original Goods Received (GR) Notes and satisfactory confirmation from the respective depot(s).
- v. The payment in respect of the installation charges will be paid on or before the 10th working day of the successive month.
- w. The Chairman & Managing Director, KSRTC SWIFT Ltd., has the right to impose penalty / fine, if any, for the violation of any of the conditions mentioned herein.
- x. Grievances, complaints shall be entertained within 30 days only. Any requests received after 30 days time shall be rejected.
- y. If the successful tenderer fails to execute the agreement as instructed in the provisional confirmation order, the Company will be at the liberty to confirm the tender in favour of the second lowest bidder, if it deems fit and loss on account of this (i.e. difference between the highest and second highest bid amount) will be realised from the defaulted tenderer by invoking provision of Kerala Revenue Recovery Act or any other law then in force.
- z. Neither KSRTC SWIFT Ltd nor contractor shall be liable for any inability to fulfil their commitments and obligations hereunder occasioned in whole or in part by Force Majeure, any of the following events resulting in material adverse effect, shall constitute force majeure events:
 - Earthquake, Flood, Inundation, Landslide.

 - Fire caused by reasons not attributable to the Licensor. Acts of terrorism.
