Objective:-

The objective of seeking Expression of Interest is to empanel contractors / consultant for the Operationalization of STPs at 3 KSRTC Depots.

Scope of Work:-

- 1. Balance Civil and allied works.
- 2. Providing electromechanical system with modern technology for running sewage treatment plants at Pathanamthitta, Thodupuzha and Aluva KSRTC depots.
- 3. Operation and maintenance of STP for 5 years.

Interested contractors / firms / consultant / Agencies may apply with their credential / information / testimonials in prescribed format as available in the KSRTC website / Office.

Work shall be progressed ahead even if only one EOI respondent is found meeting eligibility criteria.

Layout:-

The EoI has been covered under the following parts.

General Information:-

Commissioning, Operation, Maintenance of STPs in 3 KSRTC depots, Pathanamthitta, Thodupuzha and Aluva in which civil works are almost completed. The details are mentioned below;

Eligibility to Respond to an EoI:-

The agency / Contractor / Consultant / Firm should have extensive experience in the construction of sewage treatment plant with modern technology with in the specified time frame.

The consultant is required to have sufficient technical manpower in service.

Technical Requirements:-

- a). Firms carrying Indigenous design and development of effective and reliable STPs.
- b). STPs should comply with latest regulations.
- c). Modern technology to be used for the construction.
- d). Safety mechanism- The STPs should have suitable mechanical & electronic safety mechanics to ensure safety during operation.

Specifications:-

The STPs should confirm the latest version / equivalent as issued and updated time to time by Government of Kerala.

Eligibility Criteria:-

Indian entity satisfying all of the following criteria shall be considered as eligible vender for issue of EoI.

Public limited company, Pvt Limited company, Partnership firms, One person company registered as per applicable Indian Laws.
