Offering more than one brand / model will make the bid invalid.**

CA FORM No. 32 (Petty Cash Book) Book of size 42 x 33 cm having 100 sheets in duplicate (Total 200 sheets - 400 Pages) printing and lining on one side of the sheets as per specimen, using ledger (light green colour) paper of 76 GSM (Minimum) for the original copy and white paper of 57 GSM (Minimum) for duplicate copies. The pages are to be numbered serially. Perforation have to be provided to the duplicate copies. Binding:- The books have to be stab stitched neatly, having white drill bottom and the four corners are also covered with white drill, using 3 lbs cardboard covered with good quality calico. 9. Quotation should be submitted in sealed covers duly prescribing on the cover with following details.

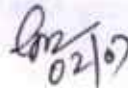
