3) Supply Schedule & Payments :-

- a) Supply of the material should be completed within the time stipulated by the corporation or within the time mutually agreed to failing which the corporation will procure the materials from other sources at the risk and cost of the bidder.
- b) Delivery period will be for a period of 1 month.
- c) Payment will be made only after receipt & acceptance at the delivery point specified in the Purchase Order.
- 4) <u>Liquidated damages for non supply and performance:</u> The successful bidders shall supply the ordered quantity of materials as per the delivery schedule given by KSRTC. If materials are not supplied as per supply schedule given by KSRTC, liquidated damages will be realized from the supplier at the rate of 0.5%

of the Cost of item per week for each week or part there of, up to a maximum deduction of 10% of the Contract prices and there after the Corporation will consider the termination of the contract at the risk and cost of the contractor.

Quotation will be opened at 15:00 hours on 30.05.2025 in the presence of the

bidders or their authorized nominees available at the time of opening. 6)

The Chairman & Managing Director, KSRTC does not bind himself to accept the 13) lowest or any offer and reserves the right to select one or more from the offers made as considered expedient.

All orders placed by the Corporation are to be executed within the time limit specified. In the event of accepting the contract any failure to supply the item on or before the specified date or in the event of the supplies being rejected, the

orders are liable to be cancelled.

In case the supply is not made within the stipulated time and as per the P.O. conditions, the Corporation will cancel the order and procure the item from any other source at the risk and cost of contractor. The KSRTC may deduct the difference in rate between the order rate and the rate actually paid for from the supplier's bill or from any money that may be due or become due to them or by initiating legal steps including revenue recovery.

16) The Chairman & Managing Director, KSRTC may reject any or all the supplies made which he consider not suitable for the purpose for which they are ordered for or because they are of inferior quality or not up to or in accordance with the specifications shown in the Tender Notice and not as per sample submitted along with the Tender and his opinion in the matter will be final and not liable to be questioned by the firm or any one on his behalf. Rejected articles should be taken back by the Contractor at his own cost.

17) The offer once made cannot be withdrawn or modified under any circumstances

18) The quantity indicated is subjected to variation by 15% more or less
