2) Introduction

KSRTC-SWIFT Ltd is a Kerala Government Company formed to support K.S.R.T.C. Now, the Kerala Motor Vehicle Department (KMVD) wanted to setup an Automated Vehicle Testing Centers in selected locations through a bidding process. To make use of the spare land available with K.S.R.T.C, the KSRTC-SWIFT Ltd is interested to participate in the tender to generate no-operational revenue by selecting suitable technology partner as a consortium member with KSRTC-SWIFT Ltd. for installation, commissioning and operation of Automated Vehicle Testing Centers.

3) Description

This is for the selection of successful entity, technology partner which involves civil construction, supply, installation testing and commissioning of vehicle inspection equipments at selected locations and requisite software for smooth operation of the centers. This center shall be operated for a period of 10 years extendable at the discretion of the KSRTC-SWIFT. The selected agency would be responsible for operating the center with technicians supervisors and operators including all test mentioned in CMVR. All test and the testing procedures are to be conducted as mentioned in GSR 652E dated 23/09/2021, GSR 797 E dated 31/10/2022 and its subsequent amendments.

4) Land for establishment

Land for establishment of ATS Center KSRTC-SWIFT will allow provide required land for establishment of ATS center at 6 locations.

There will be separate agreement between the selected agency and KSRTC-SWIFT for each ATS Center.

5) Prequalification

Eligibility criteria for participation either as single or consortium shall be as under

- a) Shall process certificate of incorporation or shop act registration or Udhogam adhar. Valid GST certification, valid permanent account number
- b) Shall have a minimum net-worth of Rs. 3 cr during the last financial year. Maximum number of consortium members is limited to 2 members with respective qualifications. One member of the consortium must be defined as a lead bidder who will be considered as bidder for the EoI.
- c) Power of attorney for lead bidder for consortium and joint bidding agreement shall be submitted. The bidder or the consortium should not have been blacklisted or terminated for default by and government or PSU's.
- d) Any vehicles manufacturer dealer service station or automobile spare parts manufacturer shall not be eligible for participate in order to avoid any conflict of interest.
- e) The bidder or it's consortium must demonstrate a successful track record in operating at least one government run ATS in India.
- f) The bidder or any consortium member must have office newly registered in India.

6) Bidders Company requirement

Bidder will be a single bidder or consortium which has sufficient knowledge of setting up of vehicle inspection center with respect to installation and commissioning of equipment per paining to vehicles inspection centers and capability to operate the center independently.

The bidder may apply individually or a consortium depending upon their financial capability and technical experience. Single bidder or lead member of a consortium shall not be permitted to participate either individual capacity or as a member of another consortium in the EoI.

7) Joint and several liabilities

Members of the consortium to which the contract is awarded shall be jointly and severely liable to KSRTC-SWIFT for execution of the projects in accordance will

be concession agreement. The agreement shall in all respect to be governed by an interpreted in accordance with Indian laws. During the period of the concision agreement the selected bidder shall may be collect and appropriate the vehicle testing fee as well as applicable GST from the users. For conducting vehicle fitness test as per CMVR. After the agreed deliver of operations the entire infrastructure and equipment in properly maintained and running condition shall be handover to KSRTC-SWIFT.

8) Scope of supply

The scope is to provide the equipments and there installation and integration in the inspection and certification center including operation of the test center.

9) List of equipments.

The inspection equipment as mentioned in CMVR/ expecting GSR each equipments shall be supplied with all required calibration certificate and software.

All the expenses for operation shall be the responsibility of selected agency. The indicative scope of consists of civil, electrical, fire, mechanical and infrastructural and utility activities as per prescribed norms and shall have to obtain required permission or license as applicable.
